Modes of Funding

The International Students can be admitted to Ph.D. program at IIT Jammu through:

- External Govt Funding: Through ASEAN/Any International Scholarship/Govt funding/Exchange scheme/Collaborative projects/Any other schemes time-to-time.
- Institute Fellowship
- Self-Financed

Eligibility Criteria

Regular (Full time):

Applicants with any of the following qualifications shall be eligible for application to a full time PhD program at the Institute.

- Master's degree in Engineering/Technology/Research or Master's degree in Science/Humanities or equivalent discipline with a good academic record.
- International applicants are required to submit GRE/GMAT/ TOEFL/ IELTS test scores as
 evidence which demonstrates their academic language ability and readiness for PhD study at IIT
 Jammu.

Or

International applicants are required to submit a certificate from the Institute (from where qualifying degree is completed) mentioning the medium of Instructions/studies followed by the candidates for Degree requirements were English.

Definition of International Applicant: Anyone who is not a citizen of India will be considered as an international applicant for the purpose of admission. Candidates who hold foreign passports (including persons with OCI or PIO cards) are eligible to apply for admission to PG programmes as foreign candidates

Application Fee:

Application Fee per department (non-refundable): Rs.300 (INR) for foreign nationals. The candidates can deposit the requisite application fee by using net banking or debit/credit card facilities. Additional charges will be applicable as per the rule of the concerned bank. The Fee will not be accepted through any other mode.

Application Procedure:

For admission to Ph.D. programmes, candidates need to register and fill the application **ONLINE** only by accessing the website: **APPLY ONLINE**.

(b) End date of the application: 15 March 2024.

General Guidelines

- Applicants will be invited on online portal on Institute website. The applicant will have to submit
 a copy of passport, documents pertaining to education qualification and SOP along with the
 application form.
- The departmental committee will shortlist the applicants and intimate the shortlisted candidates inviting them for an Interview process. This interview process can be conducted online.
- Once selected, the candidate will be issued an offer letter containing the details of fellowship.
- The candidate will have to apply for appropriate VISA in time. Any assistance related to VISA will be provided by International Relations Office of IIT Jammu. Candidate need to follow the FRRO guidelines issued and to complete the registration process.
- The International student needs to arrange for his/her medical insurance throughout his/her stay in the Institute
- An International student can transfer his/her earlier earned credits against the course works credits
 from any Institute other than IIT Jammu (as per IIT Jammu credit transfer policy from other
 Institute) to IIT Jammu through academic bank of credits.

Fellowship and Accommodation

- Maximum tenure of the fellowship: 5 years
- Fellowships will be provided for foreign students at the same rate that of Indian students by the respective funding agency. At present, Stipend per month: INR 37,000/- for initial 2 years and INR 42,000/- from 3rd years onwards (based on the performance review after 2 years).
- Annual contingency grant at par with the Indian students
- Annual travel support to attend conference and workshop at par with the Indian students
- International Students are advised to obtain travel/medical insurance on their own for full medical coverage while travelling.
- Effort will be made to provide in-campus accommodation to all international students
- The International student may be provided an exit option with a lower degree such as Masters (If the student is enrolled for Ph.D. programme) in case of any emergency. In this case International Student must fulfil the requirements of the lower degree credit requirements as per the Institute norms.
- Leaves will be at par with the Indian counterpart students.

Governing Rules for Ph.D.:

• The rules and regulations governing the Ph.D. program for Indian students will be applicable as such to the International Students.

Other Important Instructions:

The candidates are advised to read below mentioned instructions carefully before applying:

- (a) Candidates are requested to apply online only. The hard copy of the application need not be submitted. The application in any other mode/form will not be accepted.
- (b) The prescribed qualifications and experience are the minimum required and the mere fact that a candidate possesses the same will not entitle him/her for being called for an written/interview.
- (c) Departments/Centers of the Institute reserve the right to restrict the number of candidates to be called for interview to a reasonable number, based on qualifications and/or experience.
- (d) All entries should be carefully made while applying online. IIT Jammu will not be responsible for the wrong entries. Candidates shall be solely responsible for the correctness and authenticity of the information/documents provided in the online application.
- (e) Online application submitted by the candidates shall be considered final and binding. Requests for making corrections in the online application shall not be entertained.
- (f) Online application found incomplete in any form will be summarily rejected. No correspondence/communication will be entertained in this regard.
- (g) Online applications will be scrutinized, relevant documents checked/verified for their authenticity.
- (h) Students shall be governed by ordinance/regulations in vogue.
- (i) The Institute has the right to cancel, at any stage, the admission for the candidate who is found admitted to a course to which he/she is not entitled, being unqualified or ineligible in accordance with the statutes and regulations in force.
- (j) The Institute reserves the right to verify the antecedents or documents submitted by the candidate at any time during their period of study. In case it is found that the documents submitted by the candidate are not genuine, then his/her admission shall be terminated.
- (k) Merely applying for / being shortlisted/appearing for the interview / written test / or subsequent processes does not imply that a candidate will necessarily be offered admission in IIT Jammu. No request for considering the candidature in the department, other than those applied through online mode, will be entertained.
- (l) Candidates are advised to fill their correct and active e-mail addresses in the online application as all correspondence will be made by the Institute through e-mail. Test/Interview schedule will be emailed in due course to the candidates in their registered e-mail. Further, for any updates, please visit the Institute website regularly for subsequent amendments in the advertisement and results.

- (m) The candidates should ensure that they fulfill all the eligibility conditions as specified. Their admission will be purely provisional subject to confirmation that they satisfy the prescribed eligibility conditions. Mere issue of call letters to the candidates will not imply that his/her candidature has been found eligible.
- (n) After joining, Hostel and Mess facilities will be provided as per the availability and institute rules.
- (0) The fee structure is as https://www.iitjammu.ac.in/fee (The fees get revised every year on the basis of National inflation rate)
- (p) No scholarship will be provided to the students until all the required documents along with the final qualifying degree certificates are submitted physically and verified.
- (q) The candidature shall be cancelled in case of applicants fails to provide requisite documents. In this regards, the decision of the IIT Jammu shall be final.
